The Royal Government's contribution of Nu 500 million to BHTF was also made during the Special health Lottery draw.

Over the years, BHTF has been gradually increasing its support for the funding of the essential drugs and vaccines and I am confident that BHTF will grow from strength to strength to fulfil the mandates of the Royal Charter in the coming years.

About BHTF

The Bhutan Health Trust Fund, formerly known as the Trust Fund, is an initiative of the Royal Government of Bhutan, which was launched on 12th May 1998 at the WHO Headquarters in Geneva, coinciding with the 51st Session of the World Health Assembly. The Royal Charter, which was issued by His Majesty the King Jigme Singye Wangchuck in the year 2000, formally established the trust fund as the Bhutan Health Trust Fund. The Bhutan Health Trust fund plays a critical role in financing the purchase of essential drugs and helps in the funding of the sustainability of primary health care in Bhutan.

Since its inception, Bhutan Health Trust Fund (BHTF) has grown gradually to become an integral and indispensable part of the health care system. BHTF has been co-funding the cost of vaccines along with other development partners like WHO and GAVI since 2003. BHTF started funding the cost of essential drugs from 2014.

Numerous activities have been undertaken to mobilize funds for the financial sustainability of the trust fund most notably, the annual 'Move for Health.' It was an initiative undertaken by the then Minister of Health, Hon'ble Lyonpo Sangay Ngedup, who walked a distance of 560 km from Tashigang to Thimphu and raised a sum of almost USD 2 million for the trust fund. Since then, commemorative Move for Health Walks have been carried out.





Financial Overview

Status of the Investment

The operationalization of the Fund began from 2003-2004 financial year funding the implementing agencies, namely JDWNRH, DMSHI and VPDP for the procurement of the vaccines and essential drugs. BHTF has spent more than Nu.782 million. For the sustainability of the fund, various domestic investments have been made. The following graphs provide BHTF's financial overview from 2014-2018.





*BHTF's capital fund has increased by 43.81% for the fiscal year 2017-18 compared to 2016-17 mainly due to the contribution of Nu. 500 million by the Royal Government of Bhutan.


Figure 2:BHTF fund Status for 2016-17 and 2017-18

Figure 3. Investments in different financial institutions



Fund Utilization

The operationalization of the fund began in 2003 with the procurement of Hepatitis B Vaccines and ARVs. Since then, the Fund has supported the procurement of essential vaccines and essential drugs as per the details hereunder:



Highlights of 2016 - 2018

1. BHTF receives endowment fund of Nu 500 million from Royal Government of Bhutan

The Royal Government of Bhutan (RGoB) contributed Nu. 500 million as per the 'one-to-one' partnership to match the Asian Development Bank's (ADB) commitment of USD 10 million towards BHTF as part of their Health Sector Development Program. This contribution was handed over to BHTF at the Clock Tower by the Hon'ble Finance Secretary on 5th February 2018.

2. Delinking of BHTF and the drafting of the BHTF Rules and Regulations

The BHTF, as per the Royal Charter, is expected to function as a self-sustaining financial entity to ensure the sustainability of primary health care in Bhutan. However, the autonomous state could not be granted in the past, probably, due to insufficient capital fund and human resources of the secretariat. ADB committed a grant of USD 10 million to the trust fund on a condition that the BHTF be delinked from the civil service and become a self-sustaining entity.

The groundwork towards establishing BHTF as an autonomous, self-sustaining entity began in the early 2017 with the drafting of the BHTF's Rules and Regulation. Subsequently, on 19th June 2018, BHTF was formally delinked from the Royal Civil Service Commission (RCSC).

3. Special Move for Health Lottery

To meet the target of Nu 3 billion, BHTF organized a Special Move for Health Lottery in collaboration with Bhutan Lottery Limited with the proceeds from the lottery to go directly towards the continued provision of essential drugs and vaccines.

Bhutan Lottery Limited conducted the draw at Clock Tower, Thimphu on 5th February 2018, coinciding with the Birth Anniversary of the Gyalsey. A total of 300,000 tickets (15,000 booklets) were printed with each ticket costing Nu 300. A total of around 134,182 lotteries were sold, with BHTF generating a profit of around Nu. 29 million. The profit will go into funding the cost of essential drugs and vaccines in the country.

4. South Korea visit

A team led by the Chairman of the Bhutan Health Trust Fund (BHTF), Hon'ble Minister of Health, along with the Director and Programme Officer of BHTF visited Seoul, South Korea from 21-25 August 2016. The main objective of the visit was to explore and develop institutional linkages with health-related and philanthropist organizations/foundations. The visit was facilitated and coordinated by the President of Korea-Bhutan Friendship Association (KBFA) based in Seoul.

During the visit, the Bhutanese delegation was able to meet with the Minister of Health and Welfare and other key officials of the Korean Healthcare system. They shared their commitment to establishing future collaborations with the Royal Government of Bhutan and BHTF in providing medical aid and capacity building of medical personnel.


